COMMUNICATION OF CHANGES IN SHARE CAPITAL FOLLOWING THE PARTIAL EXERCISE OF THE GREENSHOE OPTION

Carpenedolo (BS), April 9, 2024 – **Palingeo S.p.A.** (ticker PAL, hereinafter also referred to as the "**Company**" or "**Palingeo**"), a leading company in the geotechnical and geognostic sectors for the construction of buildings, infrastructure, and for the consolidation of foundation soils or supporting excavation sources, announces the new composition of its share capital following the issuance of 124,200 ordinary shares of the Company.
