# PALINGEO WINS A NEW CONTRACT WORTH ABOUT 11.5 MILLION, BRINGING THE BACKLOG TO OVER 113 MILLION.

Carpenedolo (BS), October 7, 2024 – Palingeo S.p.A. (ticker PAL, hereinafter referred to as the "Company" or "Palingeo"), a leader in the fields of geotechnics and geognostics, announces the award of a contract, in a temporary joint venture with Bertini Costruzioni S.r.I. and Allara S.p.A., on behalf of the Ovest Sesia Irrigation Association. The contract concerns extraordinary maintenance interventions for the restructuring of the Cavour Canal – Section 6 "Rilevata Dora" and Section 8 – 1st lot (Vercelli).

The total value of the works is approximately 25 million euros, of which 11.3 million relates to category OS21 and is awarded to Palingeo. The work will be carried out in 2025 and the first half of 2026. The planned interventions include the consolidation of the banks through cement injections and special consolidating mixtures, as well as the restoration of containment barriers to ensure the safety and full functionality of the canal in the long term. Advanced monitoring systems will also be installed to allow constant monitoring of the canal's conditions, facilitating timely interventions in case of future issues. These works are not financed by the PNRR but are part of an independent intervention plan.

This is the most significant contract awarded by the Ovest Sesia Consortium. The Cavour Canal is one of the most significant irrigation works in Europe."
