NOTICE PURSUANT TO ARTICLE 17 OF EURONEXT REGULATION GROWTH MILAN: MATERIAL CHANGE OF SIGNIFICANT SHAREHOLDERS

In particular, the aforementioned shareholder declares that it holds 593,150 ordinary shares, equal to 10.54% of the share capital represented by ordinary shares and 6.26% of voting rights.
